Through the years the most active amateurs in Madison County have participated in this club. The present club continues the tradition of maintaining a communications club area within the ECC with multiple HF stations and computer logging equipment available to members. Club members regularly participate in contests, Field Day, various "outreach" events and also support "MCU-2" a mobile communications vehicle with amateur radio stations, antennas, etc. Theory classes for new amateurs are held as needed. Club membership is around 40 with a typical meeting attendance of 20 plus. This is an ARRL Affiliated club.
